Thai Chicken' Reaches Space: A Testament to Astronomical Safety Standards as Basil Chicken Breast Passes NASA Regulations for Astronaut Food on Axiom Mission 4 (Ax-4)

A new milestone in the history of the Thai food industry showcases the best of Thai cuisine to the world. The popular Thai dish "Basil Chicken Breast" has successfully met the stringent regulations set by NASA, ensuring it is free from contaminants and absolutely safe. Consequently, it has been officially selected as part of the astronaut food menu for the Axiom Mission 4 (Ax-4), which will transport four astronauts aboard the SpaceX Crew Dragon spacecraft to the International Space Station (ISS).

Developing a dish that meets the rigorous Space Food Standards involves ensuring safety, stability in the zero-gravity environment, and suitability for astronauts' long-term health, in compliance with NASA Standard 3001, Vol2, RevD. This challenging task required CP Foods to undergo inspections from the source of the raw materials, ensuring no growth hormones and a complete absence of antibiotics were used in the chicken rearing process. Every step of the production process, from farm to factory, was meticulously scrutinized.

This ensures that the food provided to astronauts is free from contaminants and achieves the highest safety standards. Remarkably, the farms and factories that passed these stringent checks are the same ones that supply chicken for local consumption in Thailand.


From Thai dinner tables to outer space – Thai chicken not only meets the extraordinary safety standards required for astronaut consumption but also stands as a symbol of pride in the Thai food industry's capability to fulfill global health and safety demands.

The mission gained the support and enthusiasm of notable figures such as former NASA astronaut Mike Massimino and Mr. Prasit Boondoungprasert, CEO of CPF, along with the Thai community in the United States. Celebrations were held at NASA's Kennedy Space Center in Cape Canaveral, Florida, while countless Thais in Thailand watched the rocket launch live.

The CP Mission to Space is yet another testament to the fact that "Thai chicken safety standards now meet the rigorous requirements of space food standards" and have indeed made it into space.
