Japan has permitted export starting from this 25th of December

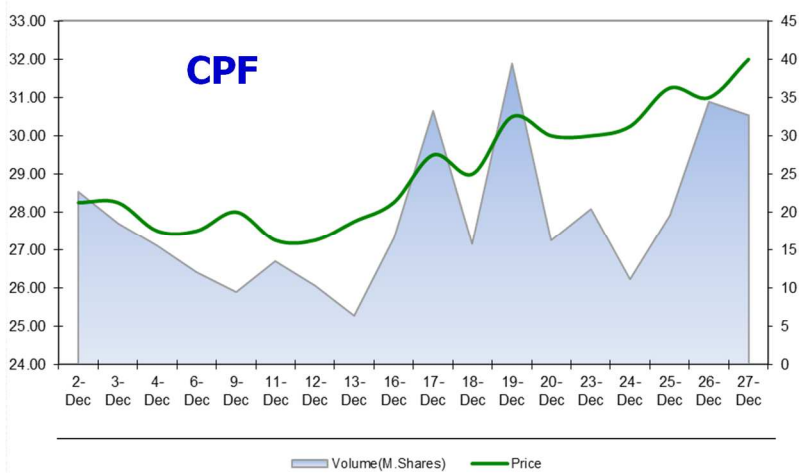
Mr. Chantanon Wannakejohn, Minister Counsellor (Agriculture) of Tokyo said that after Japan's Agricultural Policy Committee has concluded and announced on December 09, 2013 that Thailand is now free from Bird Flu, Office of Agricultural Affairs, Japan and Department of Livestock immediately proceeded and co-ordinated for details and conditions of sanitation and exported poultry certificate form with Japan's Ministries of Agriculture, Forest, and Fishery in order to be prompted for the first generation of export within 2013, at the moment the procedures and details on every matter have been completely made. Japan's Ministries of Agriculture, Forest, and Fishery have issued the certificate permitting Thailand to start exporting starting from December 25, 2013 onward. This is considered as the first permission in ten years after the prohibition to import poultry products from Thailand since January 22, 2004.

The permission for Thailand to export fresh chicken is expected to enable Thailand to export fresh and processed chicken to Japan with the number of no less than 500,000 tons (300,000 tons of fresh chicken and 200,000 tons of processed chicken) or with the value of no less than 70,000 - 80,000 million baht in 2014. The Agricultural Affairs, Tokyo, Department of Livestock, and Thai Broiler Processing Exporters Association together set up an activity to promote the quality standard, sanitary, and image of fresh chicken and products from Thailand to subsequently create awareness for Japanese consumers.
